# 3. Sections of the "Code" relied upon for this Application:

In support of this application AUPE relies upon sections 12 and 16 of the Code and on s. 27(d) of the Rules of Procedure.

### 4. Particulars of the Application:

- 1. AUPE is the certified bargaining agent for a unit of employees of Alberta Health Services described as *All employees when employed in auxiliary nursing care*. Issued 09/19/217; File No. BR-17826. Certificate No. 98-2017.
- 2. A collective agreement has been in place between the parties with effective dates of July 1, 2014 to March 31st, 2017.
- 3. AUPE's above described bargaining experience is substantially similar to that described by UNA in its Application. Because of this and because such experience is in relation to the same parties complained about by UNA, AUPE will be in a position to assist the Board in evaluating such parties' conduct in bargaining as well as whether there exists a valid labour relations purpose for granting the declaration sought by UNA.
- 4. The Board's decision on UNA's application, whether positive or negative, will have a direct impact and effect on the manner in which bargaining proceeds between AUPE and Alberta Health Services, as well, potentially, in other Health Care Institutions that AUPE represents that may have Nurse Practitioners employed. Should UNA's application be accepted it is obvious that the same labour relations purpose would apply to AUPE's bargaining relationship with Alberta Health Services as well as with other Health Care Institutions. A contrario should the application be rejected, either way, there would then be no need to relitigate these specific issues if the present application for intervener status is accepted.
